**Scoring:** Individual Events (top 8): 9, 7, 6, 5, 4, 3, 2, 1 Relay Events (top 8): 18, 14, 12, 10, 8, 6, 4, 2

**Awards:** Individual Events: 1<sup>st</sup> – 8<sup>th</sup> ribbons, Relay Events: 1<sup>st</sup> – 4<sup>th</sup> ribbons, Beads for heat winners

**Entries:** All entries must be received by email no later than 6 p.m. on Thursday, July 12<sup>th</sup>.
